UNDERSTANDING THE SPIRITUAL WARFARE BLUEPRINT: THE RULES OF ENGAGEMENT PRAYER

one-size-fits-all petition; it is a targeted assault on the works of the enemy, coupled with a declaration of God's promises over every area of life.

The prayer is often divided into distinct sections or "battle orders." These include:

- **Praise and Worship:**
Entering God's presence with thanksgiving and acknowledging His sovereignty.
- **Taking Authority:**
Verbally commanding the enemy to loose his grip on specific areas of life.
- **Armor Activation:**
Putting on each piece of the armor of God

with intentionality.

- **Declarations and Decrees:**
Speaking God's Word over situations, families, cities, and nations.
- **Praying in the Spirit:** Engaging in tongues or silent intercession as led by the Holy Spirit.
- **Thanksgiving and Closing:**
Sealing the prayer with gratitude and faith.

What makes the Rules of Engagement Prayer distinct from other intercessory prayers is its emphasis on **decrees**. Trimm teaches that a decree is a legal command issued by a person who has authority. In the

spiritual realm, believers have been given authority through Christ (Luke 10:19). Therefore, the Rules of Engagement Prayer involves speaking directly to mountains, strongholds, and circumstances, commanding them to align with God's will. This is not a prayer of begging; it is a prayer of declaration.

THE BIBLICAL FOUNDATION FOR STRATEGIC PRAYER

Critics sometimes question whether structured, aggressive prayer is truly biblical. However, a careful reading of Scripture reveals that strategic, authoritative prayer is modeled throughout the Bible. Consider Joshua commanding

the sun to stand still (Joshua 10:12-13), Elijah decreeing a drought (1 Kings 17:1), or Jesus speaking to the fig tree and calming the storm (Mark 11:23-24). These examples show that prayer was never meant to be passive. The Rules of Engagement Prayer is built on this biblical precedent.

Dr. Trimm often emphasizes that prayer is not about informing God of your problems; it is about enforcing His will on earth. Jesus taught His disciples to pray, **"Your kingdom come, Your will be done, on earth as it is in heaven"** (Matthew 6:10). The Rules of Engagement Prayer is a practical tool for seeing that prayer answered. It equips believers to

identify the strongholds that keep God's will from being manifested and to dismantle them through prayer, fasting, and the Word.

The concept of "rules of engagement" itself is a military term that defines the circumstances, conditions, and limitations under which forces may be used. In the spiritual context, these rules are found in Scripture. Believers must understand their authority, the power of the blood of Jesus, the role of the Holy Spirit, and the importance of unity. The prayer is a disciplined application of these rules to daily life.

HOW TO PRAY THE RULES OF ENGAGEMENT

PRAYER

Praying the Rules of Engagement Prayer is not about reciting a script flawlessly. It is about posture and intent. Dr. Trimm encourages believers to find a quiet place, to stand or kneel with purpose, and to pray aloud. There is power in speaking words of faith. Here is a practical guide to incorporating this prayer into your daily routine.

Begin with Spiritual Preparati

on

Before you launch into declarations, take a moment to quiet your heart. Confess any known sin. Forgive anyone who has wronged you. Ask the Holy Spirit to guide your prayers. This preparation ensures that your prayers are not hindered by unconfessed sin or a bitter heart (Psalm 66:18; Mark 11:25).

Enter with Praise and

Thanksgi ving

Start by praising God for who He is. Thank Him for His faithfulness, His love, and His power. Acknowledge that He is the Lord of hosts, the King of kings, and the victorious one. This shifts your focus from your problem to your Provider. Praise is a weapon that confuses the enemy and invites God's presence into your situation.

Put on the Armor of

God

The Rules of Engagement Prayer includes a detailed activation of each piece of armor. For each piece, pray with intention:

- **Helmet of Salvation:**

"Lord, I thank You for the mind of Christ. I pull down every thought that exalts itself against the knowledge of God. I wear the helmet of salvation to protect my mind from fear, doubt, and confusion."

- **Breastplate of Righteousness:**

"I put on the breastplate of righteousness. I am the

righteousness of God in Christ Jesus. I am protected from condemnation, shame, and accusation."

- **Belt of Truth:** "I gird myself with the belt of truth. I speak truth. I live truth. I reject every lie of the enemy."

- **Shoes of the Gospel of Peace:** "I shod my feet with the preparation of the gospel of peace. I am stable, balanced, and ready to move where God leads."

- **Shield of Faith:** "I take up the shield of faith, with which I can quench every fiery dart of the wicked one. I

believe God's Word above any circumstance."

- **Sword of the Spirit:** "I take the sword of the Spirit, which is the Word of God. I speak Scripture over my life, my family, and my nation."

Take Authority Over Spiritual Strongholds

With the armor in place, you can now take authority. This is a key component of the Rules of Engagement

Prayer. Speak directly to the spiritual forces that oppose God's purposes in your life. For example:

"I take authority over the spirit of fear. I bind you and command you to loose my mind and my emotions. I release the spirit of power, love, and a sound mind in its place (2 Timothy 1:7). I take authority over the spirit of poverty. I command financial breakthrough to manifest in my life. I decree that I am the head and not the tail, above only and not beneath (Deuteronomy 28:13)."

Be specific. Name the issues: sickness, division, lust, pride, addiction, stagnation, or whatever is hindering your walk with God. The enemy is a legalist, and he must flee when you exercise

your legal authority in Christ.

Make Declarations and Decrees

This is the heart of the Rules of Engagement Prayer. A declaration is a statement of truth based on God's Word. A decree is a legal command that creates a spiritual shift. For instance:

- "I declare that I am more than a conqueror through Christ who loves me (Romans 8:37)."
- "I decree that my children are taught of the Lord and great is

their peace (Isaiah 54:13)."

- "I decree that my household is covered by the blood of Jesus and no weapon formed against us shall prosper (Isaiah 54:17)."
- "I declare that this is my season of open doors, divine favor, and supernatural acceleration."

Speak these words with confidence, not arrogance. You are not commanding God; you are commanding the circumstances to align with His will.

Pray in the Spirit

Dr. Trimm strongly emphasizes praying in tongues or praying in a

heavenly language. According to 1 Corinthians 14:2, praying in the Spirit allows you to speak mysteries directly to God. It bypasses your limited understanding and allows the Holy Spirit to pray through you for the perfect will of God. Even if you do not speak in tongues, you can spend time in silent, deep intercession, allowing the Spirit to guide your thoughts.

Close with Thanksgi ving and

Rest

After you have prayed through your areas of concern, thank God that the battle is already won. Jesus said, "It is finished" (John 19:30). Your role is to enforce that victory through prayer. Thank Him for the breakthroughs that are coming. Thank Him for the changes you cannot yet see. Then, rest in faith. Do not spend the rest of the day worrying. If the enemy tries to bring the same fear back, remind him that you have already prayed and that the matter is settled in heaven.

Nations and Communi- ties

Dr. Trimm also encourages this prayer on a macro level: praying for governments, schools, churches, and cities.

The Rules of Engagement Prayer can be used to intercede for national revival and transformation.

PRACTICAL TIPS FOR CONSISTENCY

Developing a consistent prayer life using the Rules of Engagement Prayer requires discipline. Here are some practical suggestions:

1. **Set a Time:**
Choose a specific time each day. Morning is often preferred, as it sets the tone for the day.
