The foundation of any Ohio dissolution is a legally binding document called a separation agreement. This agreement must address every aspect of your marital life that requires legal resolution. Essential Elements

- **Child support:**

Calculate child support according to Ohio's child support guidelines. The court must approve any deviation from the standard calculation.

How Long Does a Dissolution Take?
