Modern and Contemporary Allegory

Allegory did not fade with the advent of modern literature. Instead, it adapted. In the 20th century, allegory became a powerful tool for political and social

critique. George Orwell's *Animal Farm* is a prime example. On one level, it is a story about farm animals who rebel against their human owner. use across centuries confirms the central meaning of allegory in literature: it is a flexible, enduring technique for conveying complex ideas in relatable narrative form.

KEY CHARACTERISTICS OF ALLEGORICAL WRITING

commentary on the social and legal injustices of 17th-century England. Jonathan Swift's *Gulliver's Travels* satirizes English politics, scientific pretension, and human folly through the lens of Gulliver's journeys to fantastical lands.

Moral and Religious Allegory

These allegories are designed to teach ethical or spiritual lessons. The protagonist typically undergoes a journey of temptation, trial, and redemption. The characters and

obstacles they face represent virtues to be cultivated and vices to be avoided. *Everyman* and *The Pilgrim's Progress* are prime examples of religious allegory. J.R.R. Tolkien's *The Lord of the Rings* has been read by some as a Christian allegory about the struggle between good and evil, although Tolkien himself disliked direct allegorical interpretations. In his own words, he preferred **applicability** over allegory. Despite this, the moral framework of his work clearly resonates with allegorical traditions.

Conceptual Allegory

Some allegories explore abstract ideas like time, death, justice, or beauty. They personify these concepts and place them in a narrative that examines their nature. Plato's Allegory of the Cave is a conceptual allegory about knowledge and reality. Nathaniel Hawthorne's short story "The Minister's Black Veil" is an allegory about secret sin and human isolation. The veil worn by the minister symbolizes the hidden sins that separate every person from one another and from God.

ALLEGORY AND THEIR DEEPER MEANINGS

- **Allegorical Meaning:** Christian represents every believer. His journey is the Christian life. The Slough of Despond is despair over sin. Vanity Fair represents worldly temptations. The Celestial City is heaven.
- **Key Lesson:** Salvation is attainable through faith, perseverance, and rejection of worldly distractions.

George Orwell's

Animal Farm

- **Literal Story:** Animals on Manor Farm overthrow the farmer and establish their own society, which gradually becomes tyrannical.
- **Allegorical Meaning:** The farm is Russia. The rebellion is the 1917 Revolution. Napoleon is Stalin. Snowball is Trotsky. The changing commandments represent the corruption of revolutionary ideals.
- **Key Lesson:** Revolutionary ideals can be corrupted when power concentrates in the hands of a few.

William Golding's Lord of the Flies

- **Literal Story:** A group of British schoolboys are stranded on an island. Their attempt to govern themselves descends into chaos and savagery.
- **Allegorical Meaning:** The island is a microcosm of society. Ralph represents order and democracy. Jack represents tyranny and savagery. Simon represents innate human goodness and spiritual insight. The "beast" is the primal

evil within every human.

- **Key Lesson:** Civilization is a fragile veneer. Without rules and conscience, humans revert to primitive brutality.
