## **BEST PRACTICES FOR CREATING**

## **TURNOVER LETTER**

While a sample letter provides a foundation, you should tailor it to your specific situation. Here are actionable tips:

## Be Specific and Thorough

Vague descriptions like "miscellaneous files" can cause confusion. Instead, list each file individually or group them logically (e.g., "All signed contracts for Client A, 2022-2024"). If you have hundreds of files, consider attaching an appendix or an Excel spreadsheet rather

than cluttering the letter itself. Reference the attachment in the body.

## Use Consistent Naming Conventions

Digital files should be named consistently. If the recipient can't find a file because of a different naming system, the turnover is incomplete. Agree on naming standards beforehand if possible.
