- **Nonprofit Corporation** – For charitable, educational, or religious

purposes,

If you choose a sole proprietorship or general partnership using your legal name, you might not need to register with the state immediately—but you still need business licenses and tax registrations. For LLCs and corporations, registration with the Maryland State Department of Assessments and Taxation (SDAT) is mandatory. Think carefully about liability protection and tax implications before deciding.

# Matters in the Maryland Business Registrati on Process

Your choice affects how you file taxes, how much you pay in fees, and how much personal risk you take. For example, an LLC requires filing Articles of Organization with SDAT and paying a filing fee, but it shields your personal assets from business debts. A corporation involves more complex ongoing compliance, such as

annual meetings and director elections. Many entrepreneurs starting small opt for an LLC because it balances simplicity and protection. If you are unsure, consult a business attorney or use the resources available on the SDAT website.

### **STEP 2: CHOOSE AND RESERVE YOUR BUSINESS NAME**

---

Your business name must be distinguishable from existing entities registered in Maryland. You can search the SDAT business entity database online to check name availability. If you are not ready to register immediately, you can reserve a name for a fee—typically \$25 for 30 days (check current

fees on the SDAT website).

If you operate under a name different from your legal business name (e.g., "Grace's Bakes" instead of "Grace Smith LLC"), you must register a trade name (also called "doing business as" or DBA) with SDAT. For sole proprietors and partnerships, trade names are registered at the county level in most cases, but LLCs and corporations register DBAs with SDAT. Ensure that your chosen name complies with Maryland naming rules—for example, an LLC must end with "Limited Liability Company" or "LLC".

## ASSESSMENTS AND TAXATION

### (SDAT)

This is the core of **how to register business in Maryland** for most formal entities. SDAT handles business registration, annual reports, and compliance filings. Here is what you need to do:

- For LLCs: File **Articles of Organization** online through SDAT's Maryland Business Express portal. Required information includes the business name, address, registered agent details, and manager/member names.
- For Corporations: File **Articles of**

with similar details plus number of authorized shares and director names.

- For Nonprofits: File Articles of Incorporation and obtain tax-exempt status separately.

The filing fee varies by entity type and method (online, mail, or in-person). As of 2025, online filing for an LLC costs around \$100 to \$150, while corporations may pay more. You must also designate a **registered agent** who maintains a physical address in Maryland to receive legal documents on your behalf. You can serve as your own registered agent if you have a Maryland street

address (not a PO Box).

# Using the Maryland Business Express Portal

The state encourages online registration via the Maryland Business Express portal, which streamlines the process. After filing, you will receive a confirmation and a document number. Keep this for your records—it will be used for annual reports and tax filings. Processing times vary: online filings are often approved within 24 hours, while mail submissions can take weeks.

## **STEP 4: OBTAIN AN EMPLOYER IDENTIFICATION NUMBER (EIN) FROM THE IRS**

---

An EIN is a federal tax ID number required for most businesses, especially if you plan to hire employees, form an LLC or corporation, or open a business bank account. Even if you are a sole proprietor without employees, an EIN helps separate personal and business finances. You can apply for an EIN for free on the IRS website. The application is straightforward and you receive the number immediately upon completion. This step is essential after you have your SDAT registration, as you may need to provide the EIN for state tax

registration.

## STEP 5: REGISTER FOR MARYLAND STATE TAXES

---

After your business is officially registered, you must register with the Maryland Comptroller of Maryland for state taxes. This includes:

- **Sales and Use Tax** – If you sell tangible goods or certain services, you need a sales tax license. Register online through the Comptroller's Maryland Tax Connect portal.
- **Withholding Tax** – If you have employees, you must register to withhold Maryland income tax and file returns.

- **Business Income Tax** – LLCs and corporations typically need to file annual business income tax returns. Sole proprietors report on personal returns.

The Comptroller's office also handles other specific taxes (e.g., alcohol, tobacco). Make sure you understand your tax nexus—if you only sell online to Maryland customers, you may still need a sales tax license. The state's combined sales tax rate is 6%, but some counties add a local tax.

---

## STEP 6: OBTAIN BUSINESS LICENSES AND

## PERMITS

Maryland does not have a general state business license, but many professions and industries require specific licenses. **How to register a business in Maryland** often involves checking with state and local agencies:

- **Professional Licensing** - Doctors, lawyers, real estate agents, contractors, cosmetologists, and others must obtain licenses from the Maryland Department of Labor or professional boards.
- **Health Permits** - Restaurants, food trucks, and

daycare facilities need health department approval.

- **Local City or County Licenses** - Many municipalities, such as Baltimore City or Montgomery County, require a business license. Check your local clerk's office or economic development office.
- **Home Occupation Permit** - If you operate from home, you may need a special permit from your county.

To avoid fines, research your specific industry requirements early. The Maryland Business Express website has a "One

Stop" tool that helps identify permits based on your business type.

---

## **STEP 7: REGISTER FOR UNEMPLOYMENT INSURANCE AND WORKERS' COMPENSATION**

---

If you hire employees (including yourself in some cases), you must register with the Maryland Department of Labor, Licensing, and Regulation (DLLR) for:

- **Unemployment Insurance (UI)** – Register online to pay UI taxes and report wages.
- **Workers' Compensation** – Maryland law requires most employers to carry workers' compensation insurance. You

can purchase it through private insurers or the state's fund. Sole proprietors without employees may be exempt but should check.

These registrations are separate from SDAT and the Comptroller. Keep a log of all your registration numbers (SDAT, EIN, sales tax, UI) for easy reference during tax season.

## **ADDITIONAL CONSIDERATIONS FOR MARYLAND BUSINESS REGISTRATION**

---

Beyond the basic steps, successful entrepreneurs pay attention to ongoing compliance and best practices:

# Annual Reports

All LLCs, corporations, and some other entities must file an **Annual Report** with SDAT. This is due each year on your entity's anniversary date, with a fee (typically \$300 for LLCs). Failure to file results in late fees and eventual dissolution. Mark your calendar or set up a reminder.

# Registered Agent Requirements

Your registered agent must have a physical Maryland address. If you change addresses

or move out of state, you need to update your agent. Many businesses use a commercial registered agent service for privacy and reliability.

# Business Bank Account and Records

Once you have your EIN and SDAT registration, open a dedicated business bank account to keep personal and business finances separate. This is crucial for liability protection and tax purposes. Also maintain a business license file and copies of all registrations.

# Considerations for Foreign Entities

If you already have a business registered in another state but want to operate in Maryland, you must register as a foreign entity with SDAT and pay applicable fees. This is in addition to your home state registration.
