Understanding cost analysis, net present value, benefit-cost ratios, and depreciation is critical. Environmental projects — such as wastewater treatment plants or remediation systems — require sound economic justification.

### 3. Ethics and Professional Practice      Resources and Environmental Engineering

Questions in this section cover professional responsibilities, codes of conduct, legal aspects, and sustainability ethics. The NCEES emphasizes that engineers must prioritize public health and safety, which is especially relevant in environmental work.

### 4. Water

This is a major domain. It includes hydrology, hydraulics, groundwater flow, rainfall-runoff relationships, and stormwater management. You should be comfortable with the rational method, Manning's equation, pipe flow, open channel flow, and basic groundwater principles.

Topics include physical, chemical, and biological treatment processes for drinking water and wastewater. Expect questions on sedimentation, filtration, disinfection, activated sludge, and nutrient removal. Process design parameters (e.g., detention time, loading rates) are frequently tested.

You will be assessed on atmospheric chemistry, emission standards, control technologies (e.g., scrubbers, electrostatic precipitators), and dispersion modeling. Understanding the Clean Air Act and basic plume dispersion equations is helpful.

# Hazardous Waste Management and Biology

This section covers waste characterization, landfill design, leachate management, incineration, and remediation technologies.

Regulations such as RCRA and CERCLA may appear in context.

## 8. Environmental Chemistry

Basic biochemistry, microbiology, chemical equilibrium, and reaction kinetics are included. Know the fundamentals of water chemistry (pH, alkalinity, hardness) and biological processes used in treatment.

Topics include risk assessment, toxicology, exposure analysis, and safety regulations (OSHA). This area often integrates with real-world environmental impact assessments.

## Know the Reference Handbook Inside Out

You cannot bring your own handbook, but you can search the digital version. Practice locating equations quickly. For example, common fluid mechanics equations like the Bernoulli equation or Manning's equation should be at

your fingertips.

## Skip Difficult Questions Early

Mark them for review and return later. The computer-based test allows you to flag questions and navigate between sections. Use this feature to maximize your time on questions you can answer confidently.

## Stay Calm and Hydrated

Take the optional break to rest your eyes, stretch, and drink

water. Mental fatigue can lead to careless errors. A clear mind is your greatest asset.

Can I use Environmental

Yes. NCEES approves only certain calculator models (e.g., TI-36X Pro, Casio fx-115). Make sure your calculator is on the approved list and that you are comfortable using it quickly.

Historically, NCEES reports first-time takers' pass rates around 70-75%. With adequate preparation, most examinees succeed.
