## **INTRODUCTION: YOUR JOURNEY**

### **TO THE JAG CORPS BEGINS HERE**

For many legal professionals, the dream of serving as an officer in the United States Army Judge Advocate General's (JAG) Corps represents the pinnacle of professional achievement and patriotic service. However, before you can argue

## **UNDERSTANDING THE ARMY**

### **(DCC)**

---

The Direct Commission Course is a rigorous, three-phase, four-week training program conducted at Fort Moore, Georgia (formerly Fort Benning). Unlike the traditional Officer Candidate School (OCS) which is longer and designed for enlisted soldiers seeking a commission, DCC is specifically tailored for professionals—doctors, lawyers, chaplains, and other specialized fields—who are directly commissioned into the Army. For aspiring JAG officers, this course is your first real taste of military life and the crucible where you begin your transformation from civilian attorney to Army officer.

# What Makes DCC Unique for JAG Candidates?

Many legal professionals enter DCC with Ivy League educations and years of courtroom experience. While these attributes are valuable, DCC is not an intellectual competition. It is a test of physical fitness, mental resilience, and your ability to follow orders and work as part of a team. **Succeeding at the Army's Direct Commission Course** requires you to put your ego aside, embrace discomfort, and focus on the fundamentals. You will be led by Drill Sergeants who are experts in creating

stress and building discipline. Your advanced degree and legal expertise will not shield you from the physical and emotional challenges of the course.

---

## PHASE 1: IN-PROCESSING AND THE SHOCK OF INITIAL ENTRY

---

The first few days of DCC are intentionally chaotic. You will be stripped of your personal identity and issued standard-issue military gear. You will learn the basics: how to wear the uniform, how to salute, how to address superiors, and how to stand in formation. This is where most candidates feel the most overwhelmed. The key to **The DCC Survival Guide** is to understand that this chaos is designed to break you down so the Army can rebuild you, but only if you let it. Stay calm, listen more than

you speak, and never, ever quit.

# Preparing Your Body for the Shock

Before you even set foot on Fort Moore, you must be physically prepared. The Army Combat Fitness Test (ACFT) is a core component of DCC, and you must pass it to graduate. For many attorneys who have spent years sitting at desks, this is the biggest shock. Begin a workout routine months before your report date. Focus on running (2-mile runs for time), deadlifts, push-ups, and the dreaded sprint-drag-carry. Being

physically prepared will dramatically reduce your stress level and allow you to focus on the leadership tasks that matter.

---

## **PHASE 2: TACTICAL TRAINING AND LEADERSHIP EVALUATION**

---

Once the initial shock subsides, DCC shifts into tactical training and leadership evaluation. This is where you will learn land navigation, basic rifle marksmanship, and small-unit tactics. For a future JAG officer, these skills may seem irrelevant, but they are crucial. The Army needs legal officers who understand the operational environment. You cannot advise a commander on rules of engagement if you have never carried a weapon or navigated in the woods.

## The Land Navigation Challenge

Land navigation is one of the most stressful events in DCC. You are given a map, a compass, and a set of coordinates, and you must find points in the woods—often at night and in the rain. Many candidates fail this event on their first attempt. **Becoming an Army JAG Officer** means mastering skills that are outside your comfort zone. Study the map symbols, practice using a protractor, and learn how to pace count. Team up with prior-service or military-experience candidates during training.

Their knowledge is invaluable.

## Leadership: The Peer Evaluation

A critical component of DCC is the evaluation of your leadership potential. Candidates are rotated through leadership positions (Squad Leader, Platoon Sergeant, etc.) and are evaluated by Drill Sergeants and their peers. Peer evaluations are brutal. Your fellow candidates will see you at your worst. The best way to earn their trust is to be humble, work hard, and help others. **Succeeding at the Army's Direct Commission Course** is not about being the loudest; it is about being the most reliable. Lead by example. If

the trash needs taking out, do it. If a classmate is struggling with the ruck march, help carry their gear.

---

### **PHASE 3: THE TACTICAL COMBAT CASUALTY CARE (TCCC) AND FINAL TESTING**

---

The final phase of DCC focuses on combat survival skills and culminates in a week-long field training exercise (FTX). Here, you will sleep in the field, eat MREs, and apply everything you have learned. For a legal professional, this is the ultimate test of adaptability. Your ability to remain calm under physical stress is directly transferable to the high-pressure environment of a legal practice or a combat zone. The FTX ends with a "graduation exercise" that involves a simulated patrol and a final exam.

## Mental Preparation for the FTX

Most candidates who quit DCC do so not because they are physically weak, but because they are mentally exhausted. The lack of sleep, the constant yelling, and the feeling of being under a microscope can erode your willpower. The best advice in **The DCC Survival Guide** is to adopt a "one day at a time" mentality. Don't think about the four weeks; think about the next hour. Celebrate small victories: making it to chow, completing a single patrol, or getting a compliment from a Drill

Sergeant. This mental strategy is critical for **Becoming an Army JAG Officer** who will face years of demanding assignments.

### **KEY STRATEGIES FOR JAG CANDIDATES TO EXCEL AT DCC**

Here is a distilled list of actionable strategies that will help you not only survive but excel at DCC.

## **1. Master the Fundamentals Before You Arrive**

Learn the "Soldier's Creed," the Army Corps of Engineers values (Loyalty, Duty,

Respect, Selfless Service, Honor, Integrity, Personal Courage), and the general orders of a sentry. Practice drill and ceremony from YouTube videos. Being pre-learned reduces the cognitive load on you and shows the Drill Sergeants you are serious about **succeeding at the Army's Direct Commission Course**.

## **2. Build Your "Ruck" Strong**

Your rucksack is your life during the FTX. Pack it efficiently, with the heaviest items high on your back. Tape everything to avoid noise discipline failures. Practice rucking with 35-50 pounds for miles before you report. Your

back and shoulders will thank you.

### 3. The Power of the Battle Buddy

Do not try to do DCC alone. Identify a battle buddy (preferably someone with a different background than you). If you are a tax attorney, partner with a former military paralegal or a prior-service candidate. You teach them legal strategy; they teach you how to tie a tarp and read a compass. Mutual support is the backbone of **surviving DCC**.

### 4. Manage Your Legal Ego

This is perhaps the most important advice for JAG candidates. In the civilian world, you are a professional whose opinion is sought. In DCC, you are private property, lower than a private. You will be told to do things that seem illogical or menial. Do them without question, without backtalk, and with a sense of urgency. The moment you try to argue with a Drill Sergeant using legal reasoning, you have already lost. Your ability to follow orders is the first test of your leadership.

## THE TRANSITION FROM DCC TO

### THE JAG CORPS

Graduating from DCC is a monumental achievement. You will receive your gold bars and be commissioned as a Second Lieutenant (or First Lieutenant if you have prior service or advanced degrees, though this varies). But your journey is not over. After DCC, you will attend the Judge Advocate Officer Basic Course (JA BOLC) at the Army JAG School in Charlottesville, Virginia. Here, you will learn military law, the Uniform Code of Military Justice (UCMJ), and the specifics of being a legal advisor. **Becoming an Army JAG Officer** is a two-step process: DCC makes you an officer; JA BOLC makes you a JAG.

## How DCC Prepares You for JA BOLC

DCC teaches you the discipline and resilience that makes it possible to absorb the intense legal curriculum at JA BOLC. You will be mentally toughened, physically fitter, and more adaptable. The peer relationships you built at DCC will become part of your professional network. Many JAG officers stay in touch with their DCC classmates for their entire careers. The shared hardship of Fort Moore creates a powerful bond that serves you well in the legal community.

## COMMON MISTAKES CANDIDATES MAKE AND HOW TO AVOID THEM

Based on countless after-action reviews and interviews with successful JAG officers, here are the most common pitfalls to avoid:

- **Underestimating the Physical Demands:** Do not assume that because you are smart, you can skate by on physical requirements. The APFT/ACFT failure rate among attorney candidates is disproportionately high. Train hard.
- **Isolating Yourself:** The "lone wolf" mentality fails in DCC. You need your classmates. Share snacks, offer help, and build trust.
- **Being a "Know-It-All":** The JAG

Corps values humility. If you are constantly correcting others or showing off your legal knowledge, you will alienate your peers and annoy the cadre. Be a sponge, not a fountain.

- **Quitting Mentally Before You Quit Physically:** Many candidates talk themselves into failure. They focus on the pain of the ruck march instead of the goal of graduation. Reframe your thinking: every step is one step closer to your commission.
- **Neglecting the Uniform:** Attention to detail is critical for a legal officer. If your uniform is sloppy, your attention to legal detail is suspect. Iron your uniforms, shine your boots, and

use a ruler for creases. It shows respect for yourself and the institution.
