# From Mississippi Lawyer to Literary Sensation

John Grisham was born on February 8, 1955, in Jonesboro, Arkansas, but grew up in

Southaven, Mississippi. After earning a degree in accounting from Mississippi State University and a law degree from the University of Mississippi School of Law, he practiced criminal and civil law for nearly a decade in Southaven. It was during this time that Grisham began writing fiction, often waking at 5 a.m. to write before heading to his law office.

His first novel, *A Time to Kill* (1989), was inspired by a real court case and a disturbing story he overheard. The book received modest initial sales, but when it was picked up by a major publisher and later became a successful film, Grisham's career took off. By the time he wrote *The Pelican*

*Brief*, he had already become a household name with *The Firm* (1991), which spent 47 weeks on *The New York Times* bestseller list. So, **who wrote The Pelican Brief?** It was Grisham at the peak of his early creative powers, building on the momentum of his first two novels.

## The Writing Process for The Pelican Brief

Grisham wrote *The Pelican Brief* in 1991, it was published in 1992.

The novel was born from a simple what-if scenario: what if two Supreme Court justices were assassinated? Grisham, a lawyer with a keen sense of legal procedure and political intrigue, crafted a story that felt both plausible and riveting. He has said in interviews that he outlines his books carefully, but allows the characters to drive the narrative. reaches the White House. The novel is a classic chase thriller, with Darby using her legal mind and Grantham's journalistic instincts to survive.

The question **who wrote The Pelican Brief** is often asked by readers who are struck by the novel's prescience. Written before the era of 24-hour news and social media, it explores themes of media manipulation, judicial independence, and the dangers of concentrated power. Grisham's legal background allowed him to craft a credible yet thrilling scenario.

## Critical and Commercial Success

*The Pelican Brief* debuted at number one on *The New York Times* bestseller list and remained there for several weeks. It sold millions of copies worldwide and cemented Grisham's reputation as the master of the legal thriller. Critics praised the novel's pacing, its strong female lead (a rarity in the genre at the time), and its sharp critique of corporate greed and political corruption. Some noted that the plot required a

certain suspension of disbelief, but most agreed that Grisham's storytelling was addictive.

The film adaptation followed in 1993, directed by Alan J. Pakula and starring Julia Roberts as Darby Shaw and Denzel Washington as Gray Grantham. prevail, but only at great personal cost.

Grisham's view of the media was shaped by his own experiences. After the success of *The Firm*, he became a public figure and saw how the media machine operates. When asked **who wrote The Pelican Brief**, Grisham often reflects that the novel was partly a reaction to the Watergate era and the growing cynicism about government. His skepticism resonates even more today.

# The Film

## Version

As touched upon, the 1993 film directed by Alan J. Pakula stars Julia Roberts and Denzel Washington. The screenplay (written by Pakula) simplifies the plot—for instance, the character of Gray Grantham is turned into a journalist from a Washington newspaper, while the novel had him as a freelance investigative reporter. The film also removes some subplots involving the law school and certain minor characters. Despite these changes, the film captures the core tension: a woman on the run with information that could topple a presidency.

Fans of the book often debate whether the film does justice to the

source material. Those who ask **who wrote The Pelican Brief** are often surprised to learn that Grisham had limited involvement in the adaptation. He has said that he prefers to let filmmakers do their own work, and he rarely participates in screenwriting. The film remains a faithful—if streamlined—version of Grisham’s vision.

## The Audiobook and Other Media

In addition to the film, *The Pelican Brief* has been adapted as an audiobook, narrated by various actors. The

audiobook versions are popular among commuters and fans of the legal thriller who want to experience the novel in a different format.
