- **Part 5000: Individual Organic Compounds** – This section details methods for identifying and quantifying specific organic pollutants, such as pesticides, PCBs, disinfection by-products, and volatile organic compounds (VOCs).
- **Part 6000: Metals** – Methods for

analyzing trace metals (lead, copper, arsenic, cadmium, mercury, etc.) using techniques like atomic absorption spectrophotometry (AAS) and ICP-MS.

- **Part 7000: Radiological Examination** – Procedures for measuring gross alpha, gross beta, and specific radionuclides (e.g., radium, uranium) in water.
- **Part 8000: Microbiological Examination** – This part contains classic methods for total coliforms, *E. coli*, fecal coliforms, enterococci, heterotrophic plate count (HPC), and newer molecular methods like qPCR.
- **Part 9000: Biological Examination** – Covers algae,

zooplankton, benthic macroinvertebrates, and aquatic plant identification, often used in ecological monitoring.

Each method within these parts is presented in a standardized format: a brief introduction, the principle of the method, interferences, apparatus and reagents, the step-by-step procedure for analysis and calculation, and finally, reporting requirements. # Preservation: The First and Most Critical Step

No analytical method, no matter how precise, can correct for a poorly collected sample. Standard Methods dedicates an extensive chapter to sampling techniques, emphasizing that the integrity of the sample is paramount. For example, samples for volatile organic compounds (VOCs) must be collected in glass vials with zero headspace to prevent loss of gases. Samples for

metals should be acidified to pH below 2 to keep metals in solution and prevent adsorption onto container walls. Microbiological samples must be collected in sterile bottles, chilled immediately, and analyzed within a specific time window—usually within 6 to 24 hours. The manual provides detailed tables of preservation requirements and maximum holding times for every parameter. By adhering to these protocols, laboratories ensure that the results truly reflect the water quality at the moment of collection, not a degraded or contaminated version.

## **KEY METHODS THAT DEFINE WATER QUALITY ANALYSIS**

## Biochemical Oxygen Demand (BOD5) – Method 5210

BOD is a measure of the amount of dissolved oxygen consumed by microorganisms during the decomposition of organic matter in a water sample over a 5-day incubation period at 20°C. It is a critical parameter

for assessing the organic pollution load in wastewater and for evaluating the efficiency of treatment plants. Standard Methods specifies the dilution technique (BOD5) as well as the more recent and rapid Respirometric method. The test requires careful attention to seeding, dilution water preparation, and DO measurement using a membrane electrode or Winkler titration. BOD results are used for regulatory compliance under permits like the US Clean Water Act, and for designing aeration systems in treatment plants.

## Chemical

# Oxygen Demand (COD) – Method 5220

COD measures the amount of oxygen needed to chemically oxidize organic and inorganic matter in a water sample using a strong oxidant (potassium dichromate) under acidic conditions and high temperature. Unlike BOD, COD results are available in 2-3 hours, making it a valuable tool for process control. Standard Methods outlines both the closed reflux titrimetric method and the colorimetric method. COD is especially useful for industrial wastewater that may contain toxic

compounds that inhibit microbial activity; BOD would underestimate the organic load in such cases. The relationship between COD and BOD can also indicate the biodegradability of a waste stream.

## pH and Conductivity – Methods 4500- H+ and 2510

pH measurement is perhaps the simplest yet most vital water quality test. Standard Methods provides specific guidance on electrode calibration, buffer

solutions, and temperature compensation to ensure accurate readings. Conductivity (salinity) is also straightforward, but again, the manual stresses calibration against standard potassium chloride solutions and correction for temperature. These two parameters are often the first tests performed because they influence many other analyses and are indicators of industrial contamination (e.g., low pH from acid mine drainage) or seawater intrusion in freshwater sources.

## Microbiological

### Methods: Total Coliforms and *E. coli* – Part 9221 and 9222

For public health protection, the detection of coliform bacteria is central. Standard Methods offers multiple approaches. The Most Probable Number (MPN) method (9221) uses multiple tubes with lactose broth to statistically estimate bacterial density. The Membrane Filtration technique (9222) is preferred for drinking water because it yields a direct count of colonies after

incubation on selective media. The manual also includes chromogenic substrate methods (9223) that detect both total coliforms and *E. coli* simultaneously. These tests are the backbone of regulatory monitoring for drinking water safety under the US Safe Drinking Water Act and similar regulations globally.
