- **Sediment Corers and Dredges:** These devices retrieve samples of seafloor sediment or rocks, enabling geological and paleoceanographic studies. Long sediment cores can preserve evidence of climate change spanning hundreds of thousands of years.
- **Underwater Gliders:** These buoyancy-driven robots can travel long distances (months at sea) while profiling the water column. They are used to study ocean currents, water masses, and ecosystem dynamics with high spatial resolution.
- **DNA Sequencing:** Environmental DNA (eDNA) analysis from water samples allows scientists to detect the presence of species without catching them. This approach has become a cornerstone for biodiversity assessments and tracking invasive species.

Each technological advancement pushes the boundaries of what we can discover. For instance, in 2023, scientists using a combination of satellite gravity data and sonar mapping completed a new seafloor map that doubled the coverage of previously unmapped regions, revealing thousands of new seamounts and ridges. Such progress underscores the ongoing importance of investing in oceanographic infrastructure.
