Buyers, for their part, should not rely solely on the Property Condition Disclosure Statement. While it is a valuable tool, it is no substitute for a professional home inspection. Form NYS DOS-1998, available at www.dos.state.ny.us, explicitly states that the statement is not a warranty and does not relieve the buyer of the obligation to inspect the property. Savvy buyers always conduct their own due diligence, using the disclosure statement

as a guide to identify areas of concern.
