## Upper GI Bleeding

# Interpretation of Laboratory Values

Questions on hemoglobin, hematocrit, international normalized ratio (INR), and blood urea nitrogen (BUN) are common. A key ATI real life GI bleed answer concept is that BUN may be elevated in upper GI bleeding due to blood digestion in the gut. In real life, serial hemoglobin checks guide transfusion needs, but the initial level can be misleading—a patient may have a normal hemoglobin despite massive bleeding if

fluid resuscitation has not yet diluted the blood.

## Initial Assessment and Stabilization

Upon encountering a patient with suspected GI bleeding, the nurse must first ensure airway patency, especially if the patient is vomiting blood or has altered mental status. ATI questions emphasize placing the patient in a side-lying or high-Fowler's position to prevent aspiration. In real life, supplemental oxygen, large-bore intravenous (IV) access (at least two sites), and continuous monitoring of vital signs are immediate priorities.

hypotonic solutions that could exacerbate third-spacing. The nurse watches for signs of fluid overload, particularly in elderly patients or those with cardiac impairment.

## Diagnostic Procedures and Nursing Roles

Esophagogastroduodenoscopy (EGD) is the gold standard for diagnosing and treating upper GI bleeding. ATI questions may ask about pre-procedure preparations: nil per os

(NPO) status, informed consent, and removal of dentures. Post-procedure, the nurse monitors for complications like perforation (sudden severe pain) and rebleeding (hematemesis, hypotension). For lower GI bleeding, colonoscopy or angiography may be indicated.

The ATI approach to teaching diagnostic procedures emphasizes recognition of contraindications. For instance, a patient on anticoagulants may require reversal before EGD. In real life, this requires coordination with the pharmacy and laboratory to administer vitamin K or fresh frozen plasma (FFP) as ordered.

## COMPLICATIONS TO RECOGNIZE FROM ATI REAL LIFE GI BLEED

## ANSWERS

ATI exams frequently test the nurse's ability to identify and respond to complications. In real life, these complications carry high morbidity and mortality.

# Hemorrhagic Shock

The most immediate threat is hypovolemic shock resulting from blood loss. Classic signs include tachycardia, hypotension, cool clammy skin, delayed capillary refill, and oliguria. ATI real life GI bleed answers stress that compensatory mechanisms can mask early shock in young, healthy patients. The nurse must maintain a high index of suspicion

and initiate aggressive volume resuscitation and blood product transfusion as indicated.

## Rebleeding

Even after successful endoscopic intervention, rebleeding occurs in 10-20% of patients. Nurses should remain vigilant for renewed hematemesis, increased NG output of red blood, or a sudden drop in hemoglobin. ATI questions may ask: "Which finding 24 hours after EGD indicates rebleeding?" The correct answer is often an increase in heart rate or a change in stool color from melena to bright red blood. In real life, the nurse documents these

changes immediately and notifies the physician.

## Coagulopathy and Acid-Base Imbalance

Massive transfusion can lead to coagulopathy (dilutional thrombocytopenia), hypothermia, hyperkalemia, and ionized hypocalcemia. ATI real life GI bleed answers include monitoring for prolonged prothrombin time (PT)/partial thromboplastin time (PTT) and low platelet count. In practice, the nurse administers

additional FFP, platelets, and calcium as needed while using warming devices to prevent hypothermia.

---

### PSYCHOSOCIAL AND EDUCATIONAL ASPECTS OF GI BLEED CARE

---

While ATI examinations focus heavily on technical knowledge, real-life nursing extends to patient and family education. Patients who have experienced GI bleeding need explanations about the cause, treatment, and follow-up. For example, a patient with a history of peptic ulcer disease should be counseled on avoiding nonsteroidal anti-inflammatory drugs (NSAIDs), alcohol, and smoking. Those with varices must understand the importance of avoiding

hepatotoxic substances and the need for regular endoscopy surveillance.

Anxiety is common after a significant bleed. The nurse provides empathetic support, explains each procedure, and encourages questions. ATI real life GI bleed answers often incorporate therapeutic communication techniques such as active listening and allowing time for processing.

### **BRIDGE BETWEEN ATI AND BEDSIDE: CASE SCENARIO**

Consider a 65-year-old male admitted with coffee-ground emesis and melena for two days. Vital signs: heart rate 110, blood pressure 90/60, respiratory rate 22, O2

saturation 96% on room air. The ATI-trained nurse immediately recognizes signs of hypovolemia. She establishes two large-bore IV lines, sends blood for type and crossmatch, and starts normal saline wide open. She places the patient on a cardiac monitor, inserts a Foley catheter, and keeps the patient NPO. She then calls the gastroenterology team to arrange EGD.

In an ATI exam, this sequence of actions would be considered correct prioritization. In real life, she also checks the patient's anticoagulation status (the patient had been taking warfarin for atrial fibrillation) and administers vitamin K and FFP as ordered. She notes that the

hemoglobin is 8.5 g/dL (down from 13 g/dL three months ago) and prepares for blood transfusion. After EGD reveals a bleeding duodenal ulcer with visible vessel, she administers continuous PPI infusion and monitors for rebleeding. Her **ATI real life GI bleed answers** guided her through each step, but the bedside required additional adaptation—such as coordinating with the pharmacy for warfarin reversal and ensuring the patient's INR was checked hourly.
