HOW TO START A LAUNDROMAT BUSINESS: A STEP-BY-STEP GUIDE TO BUILDING A PROFITABLE VENTURE

2. Create a Detailed Business Plan

3. Secure Financing

5. Purchase and Install Equipment

The heart of your laundromat is its machines. Invest in high-quality, energy-efficient commercial washers and dryers from reputable brands like Speed Queen, Dexter, or Huebsch.

Choose the right mix of sizes: small top-loaders for households, large front-loaders for comforters and bulky items, and perhaps a few oversized machines for rugs and dog beds.

Plan for about 1,000 to 1,200 square feet of floor space per 20-30 machines. 6. Obtain Licenses, Permits, and Insurance

water discharge permit if your facility sends wastewater into the municipal system.

Insurance is non-negotiable. Obtain general liability insurance, property insurance for the building and contents, workers' compensation (if you hire employees), and equipment breakdown coverage. Use a point-of-sale (POS) system that tracks revenue, machine usage, and expenses. Many modern machines connect to cloud-based management software,

allowing you to monitor performance remotely. Implement cashless payments to reduce theft and provide convenience—credit cards, Apple Pay, and laundromat-specific apps are popular.

Set aside a portion of revenue for maintenance and emergency repairs. A common rule is 5-10% of gross income for machine upkeep and building improvements.
