5. **Note percentile ranks and confidence intervals:** Use the same tables or supplementary pages to record these values. Ensure you understand the confidence level used (usually 90%).

It is crucial to use the correct edition of the scoring tables. The KBIT-2 has been revised over time; outdated norms may misrepresent an individual's abilities. Always verify that you are using the most recent normative data.

# Common Mistakes to Avoid

- **Ignoring age-specific norms:**  
Using an incorrect age bracket (e.g., rounding to the nearest year) can shift scores significantly, especially for young children.
- **Misreading the table layout:**

## NORMS AND STANDARDIZATION OF KBIT-2 SCORING

### LIMITATIONS AND CONSIDERATIONS WHEN USING SCORING TABLES

No assessment tool is perfect, and the **KBIT-2 scoring tables** have limitations that users must acknowledge.

## Cultural and Linguistic Factors

The KBIT-2 is available in English and Spanish, but the scoring tables are derived from English-speaking norms in the United States. The Verbal Knowledge subtest, in particular, is heavily dependent on exposure to mainstream vocabulary and cultural knowledge. The

## Test-Taker Motivation and Fatigue

Because the KBIT-2 is brief, it is less susceptible to fatigue than longer tests, but motivation and attention still affect scores. A child who is distracted or an older adult who is anxious may underperform, resulting in a depressed raw score
