Voters approved the new constitution in a special election on December 15, 1970, and it took effect on July 1, 1971. This document remains in force today.

## **STRUCTURE OF THE ILLINOIS GOVERNMENT UNDER THE CONSTITUTION**

Like the U.S. Constitution, the Illinois Constitution establishes three branches of government: legislative, executive, and judicial. Each branch has specific powers and checks on the others.

# The Legislative Branch

The Illinois General Assembly is a bicameral body consisting of the Senate and the House of Representatives.

The Senate has 59 members elected for either two or four-year terms, depending on the election cycle. The House has 118 members elected for two-year terms. The General Assembly meets in Springfield and is responsible for making state laws, approving the state budget, and confirming certain executive appointments.

One unique feature under the Illinois Constitution is that the General Assembly can be called into special session by the Governor or by a joint proclamation of the leaders. Additionally, the constitution requires a three-fifths vote of both chambers to pass legislation that increases the state's pension obligations.

# The Executive Branch

The executive power is vested in the Governor, who serves a four-year term and may be reelected. The Governor is assisted by other independently elected officers: the Lieutenant Governor, Attorney General, Secretary of State, Comptroller, and Treasurer. This “plural executive” system means that these officials are not appointed by the Governor, which diffuses power and provides additional checks.

The Illinois Constitution grants the Governor veto power over bills

passed by the General Assembly, including a line-item veto for appropriations bills. The General Assembly can override a veto with a three-fifths vote in each chamber.

# The Judicial Branch

Illinois has a unified, three-tiered court system. The highest court is the Illinois Supreme Court, composed of seven justices elected from five judicial districts (three from Cook County, one from each of the other four districts). Below the Supreme Court is the Appellate Court, and the trial courts are called Circuit Courts.

Judges are elected in partisan elections for terms ranging from six to ten years, depending on the level.

The constitution also establishes the Judicial Inquiry Board and the Courts Commission to discipline judges, ensuring accountability.

## THE ILLINOIS BILL OF RIGHTS

---

Article I of the Illinois Constitution contains the state's Bill of Rights. While it mirrors many federal guarantees, it goes further in several areas. Any effective **Illinois Constitution study guide** must highlight these key rights:

- **Due Process and Equal Protection:** Section 2

explicitly guarantees due process and equal protection, applying to all persons within the state.

The Illinois Bill of Rights also includes

provisions for workers' rights, such as the right to organize and bargain collectively (Section 25), and the right to a healthful environment (Section 33).

### KEY AMENDMENTS AND CHANGES OVER TIME

---

The 1970 Illinois Constitution includes a relatively straightforward amendment process. Amendments can be proposed by a three-fifths vote of both chambers of the General Assembly or by a constitutional convention. They must then be approved by a majority of voters statewide.

Since ratification, several amendments have been adopted. Notable examples

include:

1. **1980 - Reduction of the voting age:**

Aligned with the federal 26th Amendment, lowering the voting age to 18.

2. **1992 - Term limits for Governor and Lieutenant Governor:**

Limited to two consecutive terms.

3. **2010 - Recall of elected officials:**

Allowed voters to recall the Governor through a petition and election process.

4. **2016 - Revenue for transportation:**

Dedicated certain revenues to transportation

projects.

5. **2022 - Workers' rights amendment:**

Guaranteed the right to organize and bargain collectively, and prohibited right-to-work laws.

Studying these amendments helps students see how the constitution evolves with societal needs.

## **LOCAL GOVERNMENT AND HOME RULE**

---

One of the most distinctive features of the Illinois Constitution is its article on local government. Illinois grants home rule powers to municipalities with a population of more than 25,000, unless voters choose to revoke it. Home rule

allows cities and counties to exercise any power not specifically denied by the state, giving them greater flexibility to address local issues.

Smaller municipalities and counties can also become home rule by referendum. Home rule units can pass ordinances, levy taxes (subject to limits), and regulate local affairs without seeking specific state permission. This framework reduces legislative gridlock and empowers local decision-making.

## **TAXING AND SPENDING PROVISIONS**

---

The Illinois Constitution imposes certain fiscal constraints. Most notably, the state budget must be

balanced: the General Assembly cannot appropriate more than the estimated revenues for a given year. A simple majority is needed to pass a budget, but a three-fifths vote is required for pension increases.

On taxation, the constitution requires that taxes be uniform across similar classes of property. The state income tax is currently a flat rate, as the constitution prohibits a graduated income tax unless specifically authorized (voters rejected a graduated income tax amendment in 2020). Understanding these provisions is crucial for anyone studying the fiscal framework of Illinois.
