To bring this to life, here is a condensed sample outline for a small bakery seeking a \$25,000 grant to purchase equipment and launch a job-training program for at-risk youth.

- **Executive Summary:** Sweet Rise Bakery requests \$25,000 to purchase commercial ovens and mixers, enabling a job-training program for 10 local youth per year. The program will teach baking skills, financial literacy, and work readiness.
- **Statement of Need:** Our community has a 15% youth unemployment rate and limited vocational training. Existing programs focus on academics, not hands-on culinary skills. Businesses lack qualified entry-level workers.
- **Project Description:** Over 12 months, we will buy equipment (Month 1), recruit 10 participants (Month 2), run three training cycles of 10 weeks each, and place graduates in paid internships. A certified baker will instruct basic through advanced techniques.
- **Goals and Objectives:** Goal: Reduce youth

unemployment. Objective 1: Train 10 youth, with 8 earning a food handler’s certificate. Objective 2: Place 6 graduates in jobs within 3 months. Objective 3: Produce 500 loaves weekly to sell, supporting program costs.

- **Evaluation:** Track certificate completion, job placement rates, employer satisfaction surveys, and bakery sales revenue.
- **Budget:** \$15,000 for two deck ovens, \$5,000 for mixers, \$3,000 for ingredients/supplies, \$2,000 for instructor stipend (partial).
- **Sustainability:** After grant ends, bakery revenue and future grants will fund ongoing training. We will also apply for state workforce development funds.
