2. USE

ABBREVIATIONS AND SHORTHAND

To keep up with fast-paced discussions, develop a personal shorthand. Common abbreviations include "AI" for action item, "M" for motion, "P" for proposal, and "Q" for question. After the meeting, immediately expand these into full

sentences while your memory is fresh.

3. ASK FOR CLARIFICATION

If a decision is ambiguous or an action item lacks a deadline, politely ask for clarification. For example: "Could we confirm the deadline for the marketing report?" This shows professionalism and ensures your minutes are accurate.

4. RECORD ATTENDEES AND ABSENCES

At the start, note who is present. Pass around a sign-in sheet or ask attendees to confirm in the chat. Also record who is absent, as this may affect follow-up responsibilities.

5. STAY NEUTRAL AND OBJECTIVE

Your job is to document, not interpret. Avoid adding your own opinions or commentary. Stick to facts: what was said, decided, or agreed upon. This objectivity is vital when learning **how to take meeting minutes** professionally.

MISTAKE 4: FORGETTING TO ASSIGN DEADLINES

An action item without a due date is rarely completed. Always confirm and record deadlines during the meeting. If not stated, follow up with the assignee afterward.

MISTAKE 5: NOT DISTRIBUTING MINUTES TIMELY

Minutes lose value if they arrive days later. Aim to send the final version within 24 to 48 hours. Set a reminder to maintain this habit.
