Capitalization Rate (Cap Rate)

The cap rate is arguably the most important metric in CRE. It measures the rate of return on a property based on its net operating income (NOI). The formula is simple: $\text{Cap Rate} = \text{NOI} / \text{Property Value}$. A higher cap rate generally indicates a higher potential return but also higher risk. Net Operating Income (NOI)

Cash-on-Cash Return

Loan-to-Value Ratio (LTV)

Due Diligence
