Step 4: Complete the Documentary Transfer Tax Section

In this section, indicate that the transfer is exempt from documentary transfer tax because it is a transfer to a revocable living trust. The typical wording is: "This transfer is exempt from documentary transfer tax pursuant to California Revenue and Taxation Code Section 11911." Fill in zero dollars (\$0.00) as the tax amount. If you are unsure, consult the specific exemption codes for your county, as some counties have slightly different requirements.

Step 5: Sign and Notarize

Sign the deed in the presence of a notary public. Do not sign it beforehand. The notary will complete the acknowledgment, which includes the date, location, and their official seal. All grantors must sign. If a spouse is not on title but the property is community property, some counties still require their signature to release any potential community property interest. Check with your local recorder.

COMMON MISTAKES TO AVOID

Mismatched Names

Recording at the Wrong County

Record the deed in the county where the property is physically located, not where you live. If your property is in Los Angeles County but you reside in Orange County, the deed must go to the Los Angeles County Recorder.

RECORDING THE TRUST TRANSFER GRANT DEED

Once the deed is notarized and the PCOR is completed, it is time to record the document with the County Recorder's Office. Recording gives constructive notice to the world of the transfer. You can record in person, by mail, or electronically if your county offers that option. Keep this document with your trust paperwork. It is the proof that the property is now held in the trust.
