## WHAT IS THE BNSF CONTRACTOR ORIENTATION?

- Track inspectors and maintenance personnel
- Electricians and utility workers
- Equipment operators and truck drivers

It is important to note that even if you have completed a similar orientation for another railroad, you must still complete the **BNSF Contractor Orientation** because each railroad has its own specific rules and procedures.

## Access to BNSF Worksites

Simply put, you cannot work on BNSF property without completing the orientation. The certification is a prerequisite for site access, and BNSF security personnel regularly check for valid credentials. Contractors who attempt to bypass this requirement may be removed from the site and face additional consequences, including being banned from future work with the railroad.

### CORE COMPONENTS OF THE BNSF CONTRACTOR ORIENTATION

The **BNSF Contractor Orientation** covers a wide range of topics, each designed to address specific aspects of working safely and effectively in the railroad environment. ## Railroad Safety Fundamentals

- Any prior safety certifications that may be applicable

Having these documents ready will streamline the registration

process and help you avoid delays.

## Set Aside Adequate Time

The orientation can take several hours to complete, depending on the format and your role. Online sessions are often self-paced, but you should plan to dedicate at least four to eight hours to complete the training without rushing. In-person sessions may take a full day or longer.

### THE ORIENTATION PROCESS: WHAT TO EXPECT

## Registration and Verification
