- **Homogeneity:**

Because the particles are so small, they distribute evenly throughout the solvent, creating a single, uniform phase. You cannot distinguish the solute from the solvent, even with the most advanced optical instruments.

- **Transparency:**

Solutions are typically clear and transparent. For example, salt dissolved in water produces a solution that looks just like plain water. The particles are too

small to interfere with the passage of light waves.

- **Non-filterable:**

You cannot separate a solution by ordinary filtration. The dissolved particles pass through even the finest filter paper because they are smaller than the pores.

- **Stability:**

Solutions are permanently stable. The solute does not settle out over time, no matter how long you wait. This is due to the constant random motion of molecules (Brownian motion) and the strong interactions

between solute
and solvent.

Common Examples of Solutions

Examples of solutions are abundant in daily life. Air is a solution of nitrogen, oxygen, and trace gases. Seawater is a solution of salts in water. Brass is a solid solution of copper and zinc. In every case, the particle size is below the 1 nm threshold, making them true solutions.

The Tyndall Effect: A Signature of

Colloidal Particles

Stability and Brownian Motion

One of the most striking features of colloids is the **Tyndall effect**, which is the scattering of light by particles in a colloid. Because colloidal particles are large enough to interact with visible light waves, they cause the light to scatter in all directions. This is why a beam of light is visible when it passes through a colloid like fog, milk, or a gel. Solutions do not exhibit this effect because their particles are too small to scatter light. Suspensions can also scatter light, but their larger particles often make the mixture opaque rather than translucent.

Colloidal particles are large enough to be affected by gravity, yet they do not settle out quickly. This is because they are small enough to be constantly buffeted by solvent molecules, a phenomenon known as **Brownian motion**. This random, jittery movement keeps the particles dispersed indefinitely, provided the colloid is not destabilized by factors like heat, electrolyte addition, or freezing.

Types of Colloids of Colloids

Colloids come in many forms. An **aerosol** is a colloid of liquid or solid particles dispersed in a gas (e.g., fog, smoke). An **emulsion** is a colloid of one liquid dispersed in another immiscible liquid (e.g., mayonnaise, milk). A **gel** is a colloid where the dispersed phase forms a network that traps the liquid (e.g., jelly, agar). A **sol** is a colloid of solid particles in a liquid (e.g., paint, ink).

Milk is a classic example of a colloid. It consists of fat globules (the dispersed phase) suspended in water (the continuous phase). The fat globules range in size from about 100 nm to 1000 nm, squarely within the colloidal range. Similarly, fog is a colloid of water droplets in air, and blood is a complex colloid containing cells, proteins, and other particles.

- **Instability:**

Unlike solutions and stable colloids, suspensions are inherently unstable. They require constant agitation (stirring or shaking) to remain temporarily mixed.

Common Examples of Suspensions

Muddy water is the classic example. Soil particles, sand, and silt are suspended in water, but they will eventually settle to the bottom if left undisturbed. Other examples include paint (pigment particles in a liquid), orange juice with pulp, and the dust particles suspended in the air. In medicine, many oral suspensions are designed to be shaken before use to re-disperse the active ingredients.

WHY PARTICLE SIZE MATTERS: PRACTICAL IMPLICATIONS
