Choose Your Business Structure

Most independent labels operate as Limited Liability Companies (LLCs). This structure protects your personal assets if the label incurs debt or faces legal issues. Forming an LLC is relatively straightforward and inexpensive in most jurisdictions. You will need to register with

your state, obtain an Employer Identification Number (EIN) from the IRS, and open a dedicated business bank account. Keep your finances separate from the start—it will save you enormous headaches come tax season.

Understand Music Rights and Royalties

You cannot run a label without a working knowledge of music copyright. At its core, a record label deals with two types of rights: the master recording (the actual audio file) and the composition (the

song itself). When you sign an artist, you are typically negotiating ownership or licensing of the master recording. You need to understand performance royalties, mechanical royalties, and synchronization fees. While you can hire a lawyer for contracts, you should educate yourself on the basics. Resources like the Harry Fox Agency, SoundExchange, and ASCAP/BMI provide excellent guidance. Knowing **how to start a record label** includes knowing how to protect intellectual property.

Set Up

Your Contracts

Standard industry contracts include recording agreements, licensing deals, and distribution agreements. Even if you start with a handshake deal with a friend, get everything in writing. A simple one-page contract is better than nothing. Cover the split of revenue, ownership of masters, term length, and termination clauses. As you grow, invest in a lawyer who specializes in music law. Fair contracts build trust with artists and prevent disputes that can destroy a label.

FUNDING YOUR

LABEL

Money is the fuel that keeps your label running. You need funds for recording sessions, mixing and mastering, manufacturing (if you press vinyl), marketing, and advances to artists. There is no single right way to fund a label, but there are common paths.

- **Bootstrapping:** Most labels start with the founder's savings or income from a day job. This keeps you debt-free and fully in control.
- **Crowdfunding:** Platforms like Kickstarter and Patreon allow you to raise money directly from fans. Offer exclusive merch,

early access, or limited-edition vinyl as rewards.

- **Grants:** In some regions, arts councils and music organizations offer grants to independent labels. Research local and national programs that support music entrepreneurship.
- **Revenue Reinvestment:** Once you release music, reinvest every dollar of profit back into the label. This slow-growth approach is sustainable and builds a loyal foundation.

to start small. Release one single or EP before committing to a full album. Test the waters, learn the distribution process, and gauge audience reaction before scaling up.

Building a Partnership

A label-artist relationship should be a partnership, not a dictatorship. Be transparent about finances, timelines, and expectations. Offer

support beyond just recording: help with social media strategy, booking shows, and press outreach. When artists feel supported, they produce better work and stay loyal. Mutual respect is the foundation of every successful independent label.

PRODUCTION, DISTRIBUTION, AND RELEASE STRATEGY

Once you have signed an artist and secured funding, it is time to create and distribute music. This is where the rubber meets the road.

You do not need a million-dollar studio. Many independent labels work with home studios or small local facilities. Focus on capturing a clean, professional sound that fits your genre. If you lack engineering skills, hire a producer or engineer who shares your vision. Good production value is non-negotiable if you want to compete.

Services like DistroKid, TuneCore, and CD Baby get your music onto Spotify, Apple Music, Amazon Music, and other platforms. For physical distribution, you can press vinyl or CDs through manufacturers like United Record Pressing or Disc Makers. Many labels also use Bandcamp for direct-to-fan sales, which offers favorable revenue splits.
