WHAT IS INTUIT TURBOTAX HOME AND BUSINESS?

Intuit TurboTax Home and Business is a premium desktop and online tax preparation software that covers both personal tax returns (Form 1040) and business tax returns for sole proprietors, independent contractors, freelancers, and single-member LLCs. It is the most feature-rich option for individuals who have self-employment income, small business revenue, rental property earnings, or a combination of these.

This version goes far beyond the basic "step-by-step interview" approach. It includes specialized guidance on dozens of business deductions, asset depreciation, and industry-specific tax credits. It also supports the most common business-related forms, including the all-important Schedule C (Profit or Loss from Business), Schedule E (Supplemental Income and Loss), Form 4562 (Depreciation and Amortization), and Form 8829 (Expenses for Business Use of Your Home).

Because it is an Intuit product, you also benefit from seamless integration with other Intuit tools like QuickBooks and QuickBooks

Self-Employed. Data from these platforms can be imported directly into your return, saving you hours of manual data entry.

KEY FEATURES OF TURBOTAX HOME AND BUSINESS

Comprehensive Deduction Finder

One of the biggest advantages of using TurboTax Home and Business is its ability to uncover deductions you might not know exist. The software prompts you with simple yes/no questions about every aspect of your work life. Did you use your car for business? Did you buy a new computer? Do you have a dedicated home office? Do you pay for professional licenses, continuing education, or industry memberships? For each affirmative answer, TurboTax calculates the allowable deduction and automatically populates the correct line on the corresponding form.

For example, the **home office deduction** can be tricky: you must meet the regular and exclusive use test, and you have the option of taking the simplified method (a flat \$5 per square foot, up to 300 square feet) or the regular method based on actual expenses. TurboTax walks you through both options, compares the tax benefit, and recommends the one that is best for your situation. It then generates Form 8829 with all the necessary calculations.

Industry-Specific Guidance

Whether you are a rideshare driver, an online tutor, a freelance graphic designer, or a landlord renting out a single property, TurboTax Home and Business offers tailored interview sections. The software asks about your specific profession to surface relevant deductions. A rideshare driver, for instance, will see questions about mileage, tolls, and vehicle maintenance. A landlord will be guided through rental income, mortgage interest, repairs, and depreciation using Schedule E.

Asset Depreciation and Section 179

Capital purchases—such as a new camera for a photographer, a tablet for an artist, or a piece of machinery for a contractor—cannot be deducted all at once unless you elect Section 179 or bonus depreciation. TurboTax Home and Business handles the complex depreciation calculations automatically. It asks for the purchase date, cost, and asset class, and then calculates the correct depreciation schedule (MACRS) or the Section 179 deduction limit. This ensures you claim the maximum allowable write-off without triggering IRS red flags.

WHO SHOULD USE TURBOTAX HOME AND BUSINESS?

Seamless Import Capabilities

If you use QuickBooks Self-Employed to track your business income and expenses, you can import that data directly into TurboTax Home and Business. The software matches your categories to the appropriate tax lines. This integration dramatically reduces data entry errors and ensures consistency between your bookkeeping and your tax return. Similarly, you can import W-2s and 1099 forms from participating employers and financial institutions.

Risk of Audit Support

Tax returns that include business deductions are statistically more likely to face an IRS audit. TurboTax Home and Business offers a built-in **Audit Risk Meter** that flags entries that could increase your audit risk, such as a high home office deduction relative to your income or large entertainment expenses (which under the Tax Cuts and Jobs Act are no longer deductible). The software also provides guidance on proper documentation and recordkeeping. If you purchase the optional Audit Defense add-on, you get professional representation in the event of an audit by a credentialed tax expert.

While TurboTax offers several versions—Basic, Deluxe, Premier, Self-Employed, and Home and Business—the Home and Business version is specifically intended for taxpayers who have at least one of the following:

- **Self-employment income** from a freelance or contracting business (with or without employees).
- **A single-member LLC** or sole proprietorship (the most common business structure for small operations).
- **Rental real estate income** (even from a single rental property).
- **Multiple income streams** that combine W-2 wages, 1099 income, and business expenses.
- **Farm income** (covers Schedule F as well).

It is important to note that TurboTax Home and Business is **not** designed for partnerships, C corporations, S corporations, multi-member LLCs, or trusts. Those entities require more advanced software such as TurboTax Business. However, if you are the sole owner of a business that has not incorporated, this version should cover all your needs.

PRICING AND VALUE PROPOSITION

TurboTax Home and Business is one of the more expensive retail tax software options. However, the cost must be weighed against the value of the deductions and credits it helps you capture. The desktop CD/download version is typically priced between \$90 and \$120 (plus state filing fees), while the online version is slightly

higher because it includes cloud access, automatic updates, and the ability to start on one device and finish on another.

Consider this scenario: a freelance web designer who uses a home office, drives to client meetings, pays for software subscriptions, and buys new equipment could easily uncover \$5,000 to \$15,000 in deductions. At a 25% marginal tax rate, those deductions reduce the tax bill by \$1,250 to \$3,750. The cost of the software, even with the state return fee, is a fraction of that savings. For most users, TurboTax Home and Business pays for itself many times over—especially when compared to the cost of hiring a CPA to prepare a Schedule C and Schedule E, which can run \$300 to \$800 or more.

STEP-BY-STEP FILING PROCESS

Getting Started

After selecting the Home and Business version, you create an account and provide basic information: name, Social Security number, date of birth, and filing status. The software then asks whether you have business or rental income. Once you answer yes, it opens the business interview module.

Business Information

You will be prompted to enter your business name (if any), EIN (Employer Identification Number, or you can use your SSN as a sole proprietor), business address, and a brief description of your

principal business activity. TurboTax uses this to determine which industry-specific questions to ask later.

Income and Expenses

The software asks about all sources of business income. If you received 1099-NEC or 1099-K forms, you can enter them manually or import electronically. Next, you go through a thorough expense interview. Categories include advertising, car and truck expenses, commissions, contract labor, depreciation, employee benefit programs, insurance, interest, legal and professional services, office expenses, rent or lease (vehicles, machinery, equipment), repairs and maintenance, supplies, taxes and licenses, travel, meals and entertainment (subject to the 50% limitation), utilities, and wages paid.

For each category, TurboTax provides a plain-language explanation of what qualifies and what does not. For instance, meals with clients are 50% deductible, but lavish or extravagant meals are not. The software enforces these rules automatically.

Home Office and Vehicle Expenses

Two of the most complex deduction areas receive extra attention. For the home office, by default, the software asks detailed questions about square footage, exclusive use, and whether you have another fixed location where you work. It then calculates

both the simplified and regular methods and lets you choose the better result. For vehicle expenses, you can choose between the standard mileage rate (for 2025, the rate is set by the IRS each year) or the actual expense method. TurboTax pro-rates the deduction based on business use percentage and prompts you to convert from mileage to actual in later years if that becomes more advantageous.

Personal Return Integration

Once the business portion is complete, you finish your personal return. The same software handles your W-2, interest and dividends, deductions (such as mortgage interest, charitable contributions, and state taxes paid), credits (Child Tax Credit, Earned Income Tax Credit, etc.), and ultimately calculates your total tax liability, refund, or amount due. The business numbers flow into the personal return through Schedule C, Schedule E, and other attachments.

PROS AND CONS OF TURBOTAX HOME AND BUSINESS

Pros

Cons

 - **Overkill for very simple self-employment:** If you have only a few 1099s and negligible expenses, TurboTax Self-Employed (the middle tier) might be sufficient and cheaper.
 - **Sales tactics:** The software heavily promotes add-ons (Audit Defense, Live Expert Review), which can increase the total cost.
 - **Limited customizability:** Some power users prefer the granular control of forms-based software (like TaxAct or professional software) over the interview format.
