accumulated depreciation.

- **Intangible Assets:** Non-physical assets such as patents, trademarks, copyrights, and goodwill.
- **Long-Term Investments:** Stocks, bonds, or real estate held for strategic purposes rather than for resale.
- **Deferred Tax Assets:** Taxes paid in advance or that can be used to reduce future tax liabilities.

Step 6: Calculate Key Ratios
