The secondary market guarantees that liquidity, which makes investors willing to buy shares in the primary market in the first place.

The reward for taking on these risks is the potential for high returns. Historically, equities have outperformed bonds, real estate, and commodities over long periods (decades), making them a cornerstone of wealth-building strategies.
